**RELEASE AND INDEMNIFICATION**

Accordingly, I expressly assume all risks involved in this activity.

**INDEMNIFICATION:**

I agree to assume all responsibility for, and to indemnify, defend, and save harmless Motor Maids, Inc. from and against, any and all liabilities, judgments, claims, demands, loss, damages, destruction, injury, or death which may occur or result from my involvement in this event.

**PERSONS AFFECTED:**

I MAKE THIS RELEASE AND INDEMNIFICATION on behalf of personal representatives, my heirs, assigns, estate, and myself. Whenever the name "Motor Maids, Inc." is used, it is my intention that said name shall be construed to include the Officers and members of Motor Maids, Inc. and all persons acting in concert with Motor Maids, Inc. in connection with any event.

I stipulate that my being allowed to participate in an event is full and adequate consideration, which binds me to the provisions of the RELEASE AND INDEMNIFICATION. Furthermore, my being allowed to participate constitutes an acceptance of this document by me and by Motor Maids, Inc.
